AN ORDINANCE TO AUTHORIZE AN AGREEMENT BETWEEN THE VILLAGE OF BREWSTER AND THE OWNER OF HILLVIEW MOBILE HOME PARK TO EXTEND THE VILLAGE SANITARY SEWER SYSTEM TO THE PARK AT OWNER'S EXPENSE

Whereas, The Village of Brewster owns and operates a sanitary sewerage system, which includes a wastewater treatment plant and a sewage collection system and appurtenances; and

Whereas, Hillview Trailer Park was annexed into the Village by ordinance dated May 3rd, 2010, and currently has its sewage treated by an inadequate and failing sewage system. The owner of the Park desires to connect to the Village sewage system and pay for the improvement through a levy of assessment through the county tax collection system and reimbursement to the Village.

Now therefore be it Ordained by the Council of the Village of Brewster that:

Section 1: That the Village of Brewster and Valerie M. Luckner, Trustee of the Norma Kathryn Walker, Irrevocable Trust dated September 17, 2013, owner of the Hillview Mobile Home Park enter into an agreement for an extension of the Village Sewerage system to the Park according to the terms and conditions of the Agreement; the total cost of the project to be borne by the Owner through a levy of assessment as county taxes and reimbursed to the Village all as outlined and stated in the agreement, a copy of which is attached and is on file at Village Hall.


Section 2: That the Mayor, Village Administrator, and Village Clerk-Treasurer are hereby authorized to execute the Agreement on behalf of the Village of Brewster. A fully executed copy shall be kept at the Village Hall.

Section 3: That this ordinance shall be in full force and effect at the earliest date provided by law.


