

**A RESOLUTION AUTHORIZING THE VILLAGE ADMINISTRATOR TO COMPLETE A BIMELER
PARK EQUIPMENT PROJECT UTILIZING STATE OF OHIO NATUREWORKS PROGRAM
GRANT FUNDING AND VILLAGE FUNDS, AND DECLARING AN EMERGENCY**

WHEREAS, the State of Ohio through the Ohio Department of Natural Resources (ODNR) administers financial assistance for public recreational purposes through the ODNR Natureworks Program, and

WHEREAS, Village Council Ordinance 21-2018 authorized an application for a \$ 36,979.00 Grant for a Bimeler Park Equipment Project for the installation of outdoor fitness equipment, and

WHEREAS, the Village was approved for \$ 19,602.00 in financial assistance through this Ohio Department of Natural Resources Natureworks Grant as outlined in ODNR Local Agreement STAR-059 for the completion of a Bimeler Park Equipment Project, and

WHEREAS, Brewster Village Council desires to utilize the \$ 19,602.00 in financial assistance granted in Local Agreement STAR-059 from the ODNR Natureworks Grant Program and the Village funds obligated in the Village's Natureworks Grant application to complete a modified Bimeler Park Equipment Project.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BREWSTER, THAT:

SECTION 1: The Village Administrator is hereby authorized and directed to accept the \$ 19,602.00 grant provided by the Ohio Department of Natural Resources Natureworks Program Local Agreement STAR-059 on behalf of the Village and to provide all information and documentation required to accept the financial assistance provided by that program under Local Agreement STAR-059.

SECTION 2: Brewster Village Council authorizes and directs the Village Administrator to take all steps necessary to complete a modified Bimeler Park Equipment Project at a cost not to exceed \$ 35,000.00 utilizing the ODNR Natureworks Grant of \$ 19,602.00 and Village funds for the remaining cost for the purchase and installation of the outdoor fitness equipment.

SECTION 3: Brewster Village Council does agree to obligate the funds required to satisfactorily complete the proposed project and to become eligible for reimbursement under the terms of the Natureworks Program Local Agreement STAR-059

SECTION 4: This ordinance is an emergency to finalize the Natureworks Grant funding and shall be in full force and effect at the earliest date provided by law.
