## AN ORDINANCE AWARDING A CONTRACT FOR A BUILDING TO HOUSE ITS DIGGER/DERRICK TRUCK AND THE REST/ENTIRETY OF THE ELECTRIC DEPARTMENT, AND DECLARING AN EMERGENCY

**WHEREAS**, the Electric Department has taken delivery of a Digger/Derrick Truck, which is too large to fit into the building the current smaller Digger/Derrick Truck is currently stored, and

**WHEREAS**, due to both the cost of the Digger/Derrick Truck at \$275,000 and its hydraulics, the new Digger/Derrick Truck should be stored inside a structure, and

**WHEREAS**, the Village of Brewster Council authorized the Village Administrator to enter into contract with Engineering Associates for the design and preparation of bid specifications and the required Bid Documents for a building to house the Digger/Derrick Truck and the rest/entirety of the Electric Department, including equipment; and

**WHEREAS**, the advertisement for Bids for the completion of an Electric Department Building Project have been completed in accordance with all applicable laws,


**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BREWSTER, THAT:**

**SECTION 1:** It is determined that RBS Contractors, LLC of Massillon, Ohio was the lowest and best bidder for the Electric Department Building Project. Brewster Village Council awards a contract RBS Contractors, LLC of Massillon, Ohio for the completion of the Electric Department Building Project in accordance with the Village specifications on which the bids were received for the base contract price of \$964,000.

**SECTION 2:** The Village Administrator and Village Clerk-Treasurer are authorized and directed to execute the contract RBS Contractors, LLC of Massillon, Ohio for the completion of the Electric Department Building Project in accordance with the specifications on which the Bids were received. An executed copy of the Contract shall be kept on file in the Village Clerk-Treasurer's Office.

**SECTION 3:** This ordinance is deemed an emergency due to the need to provide for a new structure for the Electric Department's Digger/Derrick Truck, and due to the fact that it is important to take advantage of the construction season, so time is of the essence. This ordinance shall be in full force and effect at the earliest date provided by law.




