## A RESOLUTION ESTABLISHING AN ARP FUND AND DECLARING AN EMERGENCY

**WHEREAS**, the American Rescue Plan (ARP) Act of 2021 was enacted on March 11, 2021 to respond and recover from the pandemic, and

**WHEREAS**, the ARP Act was enacted to respond to the Public Health Emergency or its Negative Economic Impacts, including Assistance to Households, Small Businesses, and Nonprofits, or Aid to Impacted Industries such as Tourism, Travel, and Hospitality, and

**WHEREAS**, the ARP Act provides Premium Pay to Essential Employees or Grants to Employers to Provide Premium Pay which cannot exceed \$13 per hour or \$25,000 per worker, and

**WHEREAS**, the ARP Provides Government Services Affected by a Revenue Deduction resulting from COVID-19, relative to Revenues in the Fiscal Year Prior to the Pandemic (This is the "Revenue Loss" Provision), and


**WHEREAS**, the ARP makes Investments in Water, Sewer, or Broadband Infrastructure.

**NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BREWSTER, THAT:**

**SECTION 1:** The Village Clerk-Treasurer is hereby directed and authorized to take all necessary and appropriate steps to create a Village fund to be designated the ARP Fund.

**SECTION 2:** The source of revenue deposited into the ARP Fund shall be funds from the American Rescue Plan.


**SECTION 3:** This Resolution is deemed as an emergency in order to be ready for the expected receipt of funds within 60 days for 50% of the Village's portion.


