Resolution No. 23-2022 Passed March 21, 2022

## AN RESOLUTION ACTING ON THE RECOMMENDATION BY THE STARK COUNTY TAX INCENTIVE REVIEW COUNCIL (TIRC) REGARDING THE CRA COMMERCIAL TAX INCENTIVE (AGREEMENT) WITH BREWSTER CHEESE

**WHEREAS**, the Village of Brewster created a Community Reinvestment Area (CRA) certified on June 28, 2000; and

**WHEREAS**, subsequently the Brewster Village Council on August 28, 2009 into a CRA Commercial Tax Incentive Agreement with Brewster Dairy, Inc.; and

**WHEREAS**, annually the CRA Commercial Tax Incentive Agreement with Brewster Dairy, Inc. must be reviewed by the Stark County Tax Incentive Review Council (TIRC), which is established by Ohio Revised Code 5709.85 and Brewster's enabling legislation for its CRA; and

**WHEREAS**, when the TIRC meets, it will make a recommendation to:

- continue the tax abatement in place for Brewster Dairy
- modify the tax abatement in place for Brewster Dairy
- reject (terminate) the tax abatement in place for Brewster Dairy

**WHEREAS**, after the TIRC meets and makes a recommendation on Brewster Dairy's CRA Commercial Tax Incentive Agreement to continue, modify, or reject the current CRA tax abatement, Brewster Village Council needs to vote on that recommendation; and

**WHEREA**, that vote of Brewster Village Council must take place before March 31, 2022, so that the annual report can be submitted to the State of Ohio, and the last scheduled meeting in March is March 21<sup>st</sup>; and

### NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BREWSTER, THAT:

**SECTION 1.** Brewster Village Council hereby agrees with the recommendation of the Stark County Tax Incentive Review Council (TIRC) to continue the CRA Commercial Tax Incentive Agreement with Brewster Dairy, Inc. entered into on August 28, 2009.

**SECTION 2.** This resolution is passed on an emergency basis so that the report required to be filed with the State of Ohio before March 31, 2022 can be timely filed.

**SECTION 3.** This resolution shall be in full force and effect at the earliest date provided by law.


