AN ORDINANCE AUTHORIZING A CONTRACT FOR A VILLAGE SEVENTH STREET IMPROVEMENT AND PAVING PROJECT, AND DECLARING AN EMERGENCY

WHEREAS, the Village of Brewster made application and was awarded funding for a Seventh Street Paving & Improvement Project through the Ohio Public Works Commission (OPWC) Small Government Grants program, and

WHEREAS, under the OPWC application the Seventh Street Paving & Improvement Project the total project estimate, including construction, is \$227,500, with the Village's local match at \$116,025 (51%) and the OPWC Small Government Grant at \$111,475 (49%), and

WHEREAS, the Village contracted with Engineering Associate, Inc. to provide engineering, preparation of bid documents, and Bidding of the Seventh Street Paving & Improvement Project, and

WHEREAS, the advertisement for Bids for the Seventh Street Improvement and Paving Project has been completed in accordance with all applicable laws

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BREWSTER, THAT:

SECTION 1: It is determined that Superior Paving & Material of North Canton, Ohio was the lowest and best bidder for the Brewster Seventh Street Paving & Improvement Project which includes the following:

SECTION 2: The Village Administrator is authorized to enter into a contract with Superior Paving & Material of North Canton, Ohio for the completion of a Seventh Street Paving & Improvement Project in accordance with the specifications on which the Bids were received at a total contract price of \$ 180,405.00

SECTION 3: The Village 51% share of payment of the amounts due under the said contract shall be appropriated from the Street Improvement Fund, and the remaining 49% of the cost from OPWC grant funding.

SECTION 4: This ordinance is an emergency to allow the Village to be prepared for appropriate construction season and shall be in full force and effect at the earliest date provided by law.
