

**AN ORDINANCE AWARDING CONTRACTS FOR MAJOR EQUIPMENT

WHEREAS, Brewster Village Council desires to improve and expand the Brewster Electric Southside Substation located on Seventh Street E., and

WHEREAS, the advertisement and Bids for the Major Equipment required to complete the Southside Substation Upgrade Project has been completed according to law.
