## AN ORDINANCE AUTHORIZING THE AWARDING OF A CONTRACT FOR THE 2023 BREWSTER PAVING PROJECT

**WHEREAS**, Brewster Village Council desires to prepare and pave Village streets in 2023 through a 2023 Brewster Paving Project, and

**WHEREAS**, the advertisement for Bids for the completion of a 2023 Brewster Paving Project has been completed in accordance with all applicable laws, and

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BREWSTER, THAT:**

**SECTION 1:** It is determined that Barbicas Construction Company Inc. of Akron, Ohio was the lowest and best bidder for the base bid for the 2023 Brewster Paving Project. Brewster Village Council therefore awards a contract to Barbicas Construction Company Inc. of Akron, Ohio for the completion of the 2023 Brewster Paving Project in accordance with the Village specifications on which the Bids were received for the base contract price in the amount of \$155,078.50, with the final amount to be determined based on actual quantities and bid prices. The streets to be completed are as follows:

Street	From	To
Jackson NE	Barber	Superior
Jackson NE	Superior	Huron
Superior NE	Wabash	Mohican
Tuscarawas NW	Harmon	North Terminus

**SECTION 2:** The Village Administrator and Village Clerk-Treasurer are authorized and directed to execute the contract with Barbicas Construction Company Inc. of Akron, Ohio for the completion of the 2023 Brewster Paving Project in accordance with the specifications on which the Bids were received. An executed copy of the Contract shall be kept on file in the Village Clerk-Treasurer's Office.


**SECTION 3:** This ordinance is passed on an emergency basis to allow paving to begin as early as April to have paving completed as soon as possible, to allow the higher temperatures and longer days to provide more heat exposure for the pavement, which can help the asphalt more quickly harden and become more resistant to the damage from the elements in the future., and shall be in full force and effect at the earliest date provided by law.


