AN ORDINANCE REPEALING ORDINANCE 52-2023 AND AMENDING CHAPTER 78 PARKING SCHEDULES SCHEDULE 1. RESTRICTED PARKING OF THE VILLAGE'S CODIFIED ORDINANCES TO ADD "FIRE DEPARTMENT PARKING ONLY" TO ONE (2) PARKING SPOTS ON THE SOUTH SIDE OF EAST MAIN IN FRONT OF THE FIRE OFFICE ENTRANCE DOOR (110 EAST MAIN) AND TWO (2) SPACES ON THE SOUTH SIDE OF EAST MAIN IMMEDIATELY EAST OF THE FIRE DEPARTMENT BAYS (IN FRONT OF 142 EAST MAIN) AND ELIMINATE PARKING SPOT CLOSETS TO THE DOOR OF 110 EAST MAIN

WHEREAS, the Council of the Village of Brewster has had a request from the Fire Chief to designate an additional space on the south side of East Main by the Fire Department as "FIRE DEPARTMENT PARKING ONLY", and

WHEREAS, the Council of the Village of Brewster has had a request from the Fire Chief to eliminate the parking space on the south side of East Main by the entrance to the Fire Department at 110 East Main, and

WHEREAS, the Council of the Village of Brewster believes that it is important to further accommodate responding Fire/EMS personnel by reserving designated parking spaces on East Main, in addition to the spaces created when the Fire Station Addition was constructed off of Nickel Plate, so that spaces are available when Fire/EMS personnel respond to an emergency and to eliminate the space closest to the entrance to the Fire Department at 110 East Main so that the pumper can exit unimpeded.


NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE OF BREWSTER THAT:

SECTION 1: Brewster Village Council hereby amends Chapter 78 Parking Schedules 1. RESTRICTED PARKING of the Village's Codified Ordinances to add:

- **ELIMINATE THE PARKING SPACE ON THE SOUTH SIDE OF EAST MAIN BY THE ENTRANCE OF THE FIRE DEPARTMENT AT 110 EAST MAIN.**
- **DESIGNATE AS "FIRE DEPARTMENT PARKING ONLY" TO TWO (2) PARKING SPOTS ON THE SOUTH SIDE OF EAST MAIN IMMEDIATELY WEST OF THE FIRE OFFICE ENTRANCE DOOR (110 EAST MAIN), EXCEPT THE DAY IMMEDIATELY PRIOR TO, THE DAY OF, AND THE DAY AFTER ANY DATES DESIGNATED FOR VOTING AS LONG AS THE COMMUNITY ROOM IS USED BY THE STARK COUNTY BOARD OF ELECTIONS FOR VOTING, ON WHICH DAYS THOSE SPOTS SHALL BE DESIGNATED FOR VOTING ONLY BY THE STARK COUNTY BOARD OF ELECTIONS.**
- **DESIGNATE AS "FIRE DEPARTMENT PARKING ONLY" TWO (2) SPACES ON THE SOUTH SIDE OF EAST MAIN IMMEDIATELY EAST OF THE FIRE DEPARTMENT BAYS (IN FRONT OF 142 EAST MAIN)**


SECTION 2: This ordinance adds to and, if necessary, supersedes any and all previous ordinances on parking restrictions within Village limits, and specifically repeals Ordinance 52-2023.

SECTION 3: This matter shall be declared an emergency and shall have immediate effect due to the urgent need to eliminate a substantial risk of injury to persons and property, and interference with the firefighting response by the Village fire department and for the health and safety of Village residents.
