**A RESOLUTION AUTHORIZING THE VILLAGE ADMINISTRATOR TO EXECUTE CONTRACTS AS REQUIRED FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT FUNDING FOR THE BREWSTER HILLVIEW PUMP STATION PROJECT AND DECLARING SAME TO BE AN EMERGENCY**

WHEREAS, the Community Development Block Grant (CDBG) Program under the United States Department of Housing and Urban Development provides financial assistance to local subdivisions for capital improvements for public infrastructure, and

WHEREAS, the Community Development Block Grant (CDBG) Program in Stark County is administered by the Stark County Regional Planning Commission on behalf of the Board of Stark County Commissioners to benefit low- to moderate-income and homeless persons and families throughout Stark County, and

WHEREAS, the Village of Brewster is planning to make needed capital improvements to extend sanitary sewer to the Hillview Mobile Home Park, consisting of installation of a pump station and force main, and

WHEREAS, the Village of Brewster has received a \$40,000 Community Development Block Grant (CDBG) to construct the needed capital improvements to extend sanitary sewer to the Hillview Mobile Home Park, and

WHEREAS, the Village of Brewster has also received a \$301,000 Water Pollution Control Loan Fund Loan with principal forgiveness for up to \$40,000 to construct the needed capital improvements to extend sanitary sewer to the Hillview Mobile Home Park, and

WHEREAS, the Hillview Mobile Home Park has a consent agreement in place with Ohio EPA to extend sanitary sewer to the Hillview Mobile Home Park, to replace a failing sewerage treatment that affects the health, welfare, and safety of Village residents, and

WHEREAS, the infrastructure improvement herein above described is considered to be a priority for the community and is qualified under the CDBG program to benefit low- to moderate-income persons and families in Brewster.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BREWSTER, THAT:**

SECTION 1: That the Village Administrator is hereby authorized to execute contracts as required for the Community Development Block Grant funding for the Brewster Hillview Pump Station Project.

SECTION 2. : This resolution is deemed an emergency due to the need to execute the contractual agreement(s) for the Community Development Block Grant (CDBG) funding for this project as soon as possible, so that constructing the needed capital improvements to extend sanitary sewer to the Hillview Mobile Home Park, thereby addressing a deficiency found by the Ohio EPA for the health, safety, and welfare of Village residents can proceed as soon as possible, which shall benefit the Village by protecting the public peace, health and safety of its residents. This ordinance shall be in full force and effect upon passage.


