

AN ORDINANCE VACATING A PORTION OF HARRIMAN STREET SW

WHEREAS, Brewster Cheese of 800 Wabash Avenue S petitioned Brewster Village Council to vacate the portion of Harriman Street SW that runs approximately 323 feet from Seventh Street SW to the south property line of Parcel 7000070 and between Parcels 7000654 and 7000070 on its west border and Parcels 7000533 - 7001447 on its east border, and

WHEREAS, as directed in ORC Section 713.02, the petition from Brewster Cheese of 800 Wabash Avenue S, Brewster, Ohio to Brewster Village Council was forwarded to the Brewster Planning Commission for their review, consideration, and recommendation; and

WHEREAS, on May 18, 2017 the Brewster Planning Commission reviewed the request and after careful consideration unanimously recommended to Brewster Village Council that this portion of Harriman Street SW be vacated.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BREWSTER, THAT:

SECTION 1: Brewster Village Council is in agreement with the Brewster Village Planning Commission that per the Brewster Cheese petition that the above stated portion of Harriman Street SW shall be vacated.

SECTION 2: Brewster Village Council further finds that the portion of Harriman Street SW in question is not needed for use as a public roadway or other public purposes, and that there is good cause for vacation of said street as requested, and that the vacation will not be detrimental to the general interest of the public.

SECTION 3: The aforementioned portion of Harriman Street SW that runs approximately 323 feet from Seventh Street SW to the south property line of Parcel 7000070 and between Parcels 7000654 and 7000070 on its west border and Parcels 7000533 - 7001447 on its east border, respectively, shall be vacated on the condition that the Village Administrator shall insure that any easements that may be necessary for current or future construction, maintenance, and operation of various public utilities be included.

SECTION 4: That in accordance with Village Ordinance 15-2004 the Village Policy for Vacation of Alley and Street, the Village Administrator has collected from the Petitioner a \$ 1000 refundable deposit to cover any expenses for surveying, deed preparation, recording, and any legal procedures to be incurred by the Village. Any unused portion of the \$ 1000 shall be refunded. The Petitioner shall be expected to pay any excess costs above \$ 1000, and the vacation of the above stated portion of Harriman Street SW will not be finalized or recorded with Stark County, Ohio until all costs are reimbursed by the Petitioner.

SECTION 5: The Village Administrator is directed to have a Vacation Plat prepared by a licensed surveyor vacating the above cited portion of Harriman Street SW and assigning new Lot numbers, where applicable.

SECTION 6: The Village Administrator acting as Village Platting Commissioner is directed to review the prepared Vacation Plat and upon its acceptance, to endorse upon the Plat the action of this Village Council of vacating said portion of Harriman Street SW, and to cause said Plat to be recorded with the Recorder of Stark County, Ohio

SECTION 7: The Village Administrator is further directed that upon completion of the above, that the Auditor of Stark County, Ohio shall be notified of the vacation, and provided with any appropriate documentation of same.

SECTION 8: This ordinance shall be in full force and effect at the earliest date provided by law.
