A RESOLUTION AUTHORIZING THE AMENDMENT AND APPROPRIATION OF ADDITIONAL FUNDS FOR 2023

WHEREAS, the Income Tax Collections have been underestimated for 2023 and the Village investments have brought in more interest than expected thus allowing for more funds to be available for appropriation and;

WHEREAS, the Village has declared items no longer necessary and put the items up for public auction, and declared other items unusable and recycled those items, and;

WHEREAS, The Village of Brewster has received and expects to receive more money from the OneOhio Opioid Settlement through the Ohio Attorney General, and;

WHEREAS, the Utility Funds had received more in grants, taps, reimbursements and sale of assets than previously expected.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BREWSTER, STARK COUNTY, OHIO THAT:

\$ 25,500.00 for the Police Income Tax Fund
\$ 12,500.00 for the Fire Income Tax Fund
\$ 2,300.00 for the OneOhio Opioid Settlement Fund
\$ 10,000.00 for the Recreation Fund
\$ 140,584.00 for the Capital Construction (Grants) Fund
\$ 8,900.00 for the Capital Projects Fund
\$ 11,386.00 for the Water Fund
\$ 5,000.00 for the Sewer Fund
\$ 102,637.00 for the Electric Fund
\$ 422.90 for the Water Replacement Fund
\$ 450.00 for the Cemetery Endowment Fund
