**AN ORDINANCE OF SUPPLEMENTAL APPROPRIATIONS AND AMENDING ORDINANCE #07-2024 RELATING TO APPROPRIATIONS AND PROVIDING FOR THE TRANSFER OF FUNDS WITHIN SAID FUNDS FOR THE FISCAL YEAR ENDING DECEMBER 31, 2024**

**WHEREAS**, the Village Clerk-Treasurer has advised Village Council that a reallocation of the funds that were provided in Ordinance #07-2024 is necessary, and

**WHEREAS**, Brewster Village Council wishes to amend Ordinance #07-2024 to authorize such an allocation of funds.

**BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BREWSTER, STARK COUNTY, OHIO, THAT:**

**SECTION 1: That there be and hereby is transferred within the 2024 appropriation within the Street CR&M Fund of the Village of Brewster, Ohio, the following:**

- \$ 4,500 from B1-6B-250 Capital Outlay to B1-6B-211 Wages
- \$ 7,500 from B1-6B-250 Capital Outlay to B1-6B-246 Repairs
- \$ 15,000 from B1-6B-250 Capital Outlay to B1-6C-250 Capital Snow Removal

**SECTION 2: That there be and hereby is transferred within the 2024 appropriation within the Police Car and Equipment Fund of the Village of Brewster, Ohio, the following:**

- \$ 8,850 from B8-1A-246 Repairs to B8-1A-250 Capital Outlay

**SECTION 3: That there be and hereby is transferred within the 2024 appropriation within the Capital-Construction Projects Fund of the Village of Brewster, Ohio, the following:**

- \$ 40,000 from D1-6A-250-7 Water Trans Project to D1-6A-250-9 Alternate 1 Tuscarawas Project


**SECTION 4: That there be and hereby is transferred within the 2024 appropriation within the General Fund of the Village of Brewster, Ohio, the following:**

- \$ 1,000 from A1-7E-250 Capital to A1-1A-242 Uniforms


**SECTION 5: That there be and hereby is transferred within the 2024 appropriation within the Water improvement Fund of the Village of Brewster, Ohio, the following:**

- \$ 20,000 from E7-5C-211 Wages to E7-5C-250 Capital Outlay




