**A RESOLUTION AUTHORIZING THE VILLAGE ADMINISTRATOR OF THE VILLAGE OF BREWSTER TO PREPARE AND SUBMIT AN APPLICATION TO PARTICIPATE IN THE OHIO DEPARTMENT NATURAL RESOURCES LAND AND WATER CONSERVATION FUND PROGRAM AND TO EXECUTE CONTRACTS AS REQUIRED**

WHEREAS, the State of Ohio through the Ohio Department of Natural Resources, administers financial assistance for public recreation purposes, through the federal **Land and Water Conservation Fund** program and

WHEREAS, the Village of Brewster desires financial assistance under the **Land and Water Conservation Fund**

NOW, THEREFORE, be it resolved by the Village of Brewster:

**Section 1:** That the Village of Brewster approves filing an application for financial assistance from the Ohio Department of Resources Land and Water Conservation Fund.

**Section 2:** That the Village Administrator of the Village of Brewster is hereby authorized and directed to execute and file an application with the Ohio Department of Natural Resources and to provide all information and documentation required to become eligible for possible funding assistance.

**Section 3:** That the Village of Brewster does agree to obligate the funds required to satisfactorily complete the proposed project and become eligible for reimbursement under the terms of the **Land and Water Conservation Fund**.

**Section 4:** This resolution is being passed on an emergency basis, and shall be in full force and effect at the earliest date provided by law, due to the fact that the deadline for application is November 16<sup>th</sup>, 2020 and that in order to make a timely application, the ordinance must be passed prior to that date.
