**AN ORDINANCE OF SUPPLEMENTAL APPROPRIATIONS AND AMENDING ORDINANCE #23-2023 AND ORDINANCE #53-2023 RELATING TO APPROPRIATIONS AND PROVIDING FOR THE TRANSFER OF FUNDS WITHIN SAID FUNDS FOR THE FISCAL YEAR ENDING DECEMBER 31, 2023 AND DECLARING AN EMERGENCY**

**WHEREAS**, the Village Clerk-Treasurer has advised Village Council that a reallocation of the funds that were provided in Ordinance #23-2023 and Ordinance #53-2023 is necessary, and

**WHEREAS**, Brewster Village Council wishes to amend Ordinance #23-2023 and Ordinance #53-2023 to authorize such an allocation of funds.

**BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BREWSTER, STARK COUNTY, OHIO, THAT:**

**SECTION 1: That there be and hereby is transferred within the 2023 appropriation within the General Fund of the Village of Brewster, Ohio, the following:**

- \$ 8,000 from A1-1A-250 Capital to A1-1A-230 Contractual Services
- \$ 1,500 from A1-7E-250 Capital to A1-7F-232 Insurance
- \$ 500 from A1-7L-240 O&M to A1-7L-211 Wages
- \$ 100 from A1-7L-240 O&M to A1-7L-212 Benefits

**SECTION 2: That there be and hereby is transferred within the 2023 appropriation within the Street CR&M Fund of the Village of Brewster, Ohio, the following:**

- \$ 1,000 from B1-6B-250 Capital to B1-6D-240 Storm Sewers

**SECTION 3: That there be and hereby is transferred within the 2023 appropriation within the Fire Operations Fund of the Village of Brewster, Ohio, the following:**

- \$ 15,000 from B9-1B-250 Capital to B9-1B-230 Contractual Services
- \$ 40,000 from B9-1B-250 Capital to B9-1B-240 Operation and Maintenance

**SECTION 4: That there be and hereby is transferred within the 2023 appropriation within the EMS Fund of the Village of Brewster, Ohio, the following:**

- \$ 2,000 from B10-2B-250 Capital to B10-2B-239 Refunds
- \$ 2,000 from B10-2B-250 Capital to B10-2B-244 Gas and Oil

**SECTION 5: That there be and hereby is transferred within the 2023 appropriation within the Electric Fund of the Village of Brewster, Ohio, the following:**

- \$ 2,000 from E3-5D-250 Capital to E3-5D-244 Gas and Oil

**SECTION 6: That there be and hereby is transferred within the 2023 appropriation within the Sewer Replacement Fund of the Village of Brewster, Ohio, the following:**

- \$ 40,000 from E5-5C-250 Capital to E5-5C-234 Engineering


**SECTION 7: That there be and hereby is transferred within the 2023 appropriation within the Water Replacement Fund of the Village of Brewster, Ohio, the following:**

- \$ 15,000 from E7-5C-250 Capital to E7-5C-234 Engineering


