

**AN ORDINANCE ACCEPTING A FEMA ASSISTANCE TO FIREFIGHTERS GRANT (AFG)
AND FOR THE PURCHASE OF AIR PACKS FOR THE BREWSTER FIRE DEPARTMENT,
AND DECLARING AN EMERGENCY**

WHEREAS, the Village of Brewster has been awarded a grant through the Federal Emergency Management Agency (FEMA) for an Assistance to Firefighters Grant (AFG) for the purchase of twenty Air Packs for the Brewster Fire Department, and

WHEREAS, the Assistance to Firefighters Grant as written has an approved budget of \$ 141,995.00 with the approved amount from AFG in the amount of \$ 135,233.33 and with a Village contribution of five percent (5%) of the total at an amount of \$ 6761.67.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BREWSTER, OHIO, THAT:

SECTION 1: The Village of Brewster shall accept grant funds in the amount of \$ 135,233.33 from the awarded FEMA Assistance to Firefighters Grant and shall obligate Village Fire Funds in the amount of \$ 6731.67 to fulfill the proposed and awarded project for the purchase of twenty Firefighters' Self Contained Breathing Apparatus (SCBA) units which shall include harness/backpack, face piece, and two air cylinders at an approved budget of \$ 141,995.00.

SECTION 2: In accepting this award the Village acknowledges that the following documents are incorporated into the award: A Summary Award Document, Award Agreement Articles, Award Obligor Document, and by reference the 2018 AFG Notice of Funding Opportunity.

SECTION 3: The Village Administrator and Village Clerk-Treasurer are authorized and directed to execute and take all measures required to accept the AFG Award from FEMA and required to fulfill the obligations of the award for the purchase of the twenty SCBA units for the Village Fire Department.

SECTION 4. This ordinance is necessary for the protection of the public peace, health and safety and is deemed an emergency, and this ordinance shall be in full force and effect upon passage.
