Resolution No. 69-2023 Passed December 18th, 2023

A RESOLUTION AUTHORIZING AN ADVANCE FOR THE POLICE TRAINING FUND FROM THE GENERAL FUND

WHEREAS, in 2016 Brewster Village Council had been advised that the State of Ohio mandates that all law enforcement divisions in the State of Ohio shall provide law enforcement training annually to all commissioned officers. This training will be provided to comply with Continued Professional Training mandates from the Ohio Peace Officer Training Commission, and;

WHEREAS, the State of Ohio provides funds to support annual Continued Professional Training of these commissioned officers, and;

WHEREAS, the Village of Brewster created a separate fund in 2016 with the Ohio State Auditor's approval as required by Ohio Revised Code Section 5705.12, and;

WHEREAS, the State of Ohio originally provided funds in advance but changed in 2023 to make this a reimbursement program, and;

WHEREAS, with this change creating a negative balance in the Police Training Fund, the Village Clerk-Treasurer is requesting that Brewster Village Council approve an advance to the Police Training Fund from the General Fund in the amount of \$2,000 to be reimbursed to the General Fund upon receiving the reimbursement from the State of Ohio,

NOW THEREFORE BE IT RESOLVED THAT:

SECTION 1. The Clerk-Treasurer is hereby directed and authorized to take all steps necessary or appropriate, in accordance with the Ohio Revised Code and the State Auditor's Office, advance the Police Training Fund the amount of \$2,000 from the General Fund.

SECTION 2. The Clerk-Treasurer is hereby directed and authorized to take all steps necessary or appropriate, in accordance with the Ohio Revised Code and the State Auditor's Office, reimburse the General Fund upon receipt of the funds from the State of Ohio. The reimbursement is expected to be received in January, 2024.

SECTION 2: This resolution is deemed an emergency as it needs to be in effect before the end of the year and shall be in full force and effect at the earliest date provided by law.


