

AN ORDINANCE THAT AUTHORIZES THE PURCHASE OF A 2017 FORD F-450 4X4 LIFELINE CUSTOM TYPE I AMBULANCE FOR THE BREWSTER FIRE DEPARTMENT

WHEREAS, Brewster Village Council hereby declares that it is in the best interest of the Village of Brewster to purchase a new Ambulance to replace a well-used 2003 Ford E450 Ambulance; and

WHEREAS, Brewster Village Council has determined that it is in the best interest of the Village to purchase a 2017 Ford F-450 4X4 Custom Type I Ambulance built by Lifeline and purchased from Pfund Superior Sales Company of Ravenna, Ohio through the Ohio Cooperative Purchasing Program administered by the Ohio Department of Administrative Services as provided under Ohio Revised Code Section 125.04 and Section 731.14

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BREWSTER, THAT:

SECTION 1: The Village Administrator and Village Clerk are authorized to take all steps necessary to enter into a contract for the purchase of a 2017 Ford F-450 4X4 Custom Type I Ambulance built by Lifeline and purchased from Pfund Superior Sales Company of Ravenna, Ohio through the Ohio Cooperative Purchasing Program at a contract price that shall not exceed \$ 211,065.00. Said contract for the 2017 Ford F450 4X4 Custom Type I Lifeline Ambulance will be in accordance with the specifications submitted by Pfund Superior Sales Company of Ravenna, Ohio to the Village dated September 21, 2017.

SECTION 2: The contract price shall be reduced by Pfund Superior Sales Company by \$ 4600.00 for a Government Price Concession (GPC) credit from the Ford Motor Company. The contract as written provides a minimum Trade-In value for the 2003 Ford E450 Ambulance of \$ 12,000.00 from Pfund Superior Sales Company. The contract also provides that the Village may take Bids on the 2003 Ford E450 Ambulance and sell the 2003 Ford E450 Ambulance to the best Bidder.

SECTION 3: The Village Administrator shall at the appropriate time take Bids on the 2003 Ford E450 Ambulance. The acceptance of Bids is intended to maximize the return on the value of the 2003 Ford E450 Ambulance, and if a successful Bid is more than the \$ 12,000.00 Trade-In value the 2003 Ford E450 Ambulance shall be sold to the best Bidder.

SECTION 3: The purchase of the 2017 Ford F450 4X4 Custom Type I Lifeline Ambulance will be a joint effort of the Village of Brewster and the Brewster Firemen's Association funded in the following manner:

- a. The Brewster Fire Association share = \$ 14,000.00
- b. Trade-In or Sale of the 2003 Ford E450 Ambulance = \$ 12,000.00 (Minimum Trade-In)
- c. The Village Ambulance Replacement Fund share = Contract price minus (a + b)
- d. The maximum to be paid from the Village Ambulance Replacement Fund shall be \$ 180,465.00

SECTION 4: Funds for the Village's share purchase of the 2017 Ford 2017 Ford F450 4X4 Custom Type I Lifeline Ambulance shall be appropriated from the Village Ambulance Replacement Fund as directed by Council

SECTION 5: Funds for the Brewster Firemen's Association's share for the purchase of the 2017 Ford 2017 Ford F450 4X4 Custom Type I Lifeline Ambulance shall be provided by the Brewster Firemen's Association at the time of delivery of the 2017 Ford F450 Ambulance

SECTION 5: This ordinance shall be in full force and effect at the earliest date provided by law.
