

**A RESOLUTION AUTHORIZING THE APPROVAL OF THE DISCONTINUATION AND DISPOSITION OF CERTAIN DIESEL FACILITIES OF OHIO MUNICIPAL ELECTRIC GENERATION OMEGA JV2 ASSETS AND THE SALE OF THE OMEGA JV2 ASSETS BY AMERICAN PUBLIC POWER (AMP), AND DECLARING AN EMERGENCY**

**WHEREAS**, the Village of Brewster is a participant in the Ohio Municipal Electric Generation Agency Joint Venture No. 2 ("OMEGA JV2") Project, and

**WHEREAS**, Ohio Municipal Electric Generation Agency Joint Venture No. 2 ("OMEGA JV2") owns, operates and maintains certain electric generating units and facilities, and;

**WHEREAS**, AMP Staff has advised the OMEGA JV2 Participants that beneficial operation of one (1) diesel reciprocating internal combustion engine (RICE) generating unit and related facilities located and sited in Bowling Green, Ohio is no longer feasible due to licensing, operating conditions, and other causes beyond OMEGA JV2's control.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BREWSTER AS AN OMEGA JV5 PARTICIPANT THAT:**

**SECTION 1:** OMEGA JV2 is unable to beneficially operate, due to licensing, operating conditions, or other causes beyond its control, the one (1) diesel RICE generating unit and related facilities described in the attached Exhibit (collectively, the "Assets").

**SECTION 2:** Pursuant to the OMEGA JV2 Agreement, the operation of the Assets shall be discontinued and offered for sale by American Municipal Power, Inc. ("AMP"), as agent for OMEGA JV2.

**SECTION 3:** The Assets may be sold to a Participant at an amount not less than \$30,000 on an AS-IS, WHERE-IS basis; provided, however, that if all of the Assets are sold to a Participant that assumes all asset retirement obligations, the sale price may be reduced by the reasonably estimated amount of asset retirement obligations avoided by the non-purchasing Participants.

**SECTION 4:** If no Participant purchase the Assets, they shall be offered for sale to the public on an AS-IS, WHERE-IS basis. Any sale to a third party must be approved by the Officers of OMEGA JV2.

**SECTION 5:** AMP is authorized, as agent for OMEGA JV2, to execute such agreements as may be necessary to effectuate the sale of the Assets, including bills of sale, termination or assignment of the real property lease associated with the Assets, and termination or assignment of any services agreements related to the Assets.

**SECTION 6:** This Ordinance shall be an emergency measure necessary to provide the sale of the OMEGA JV2 assets in a timely fashion and shall be in full force and effect upon its passage.
