

**AN ORDINANCE AWARDING A CONTRACT FOR THE INSTALLATION OF MATERIAL AND EQUIPMENT FOR THE SOUTHSIDE SUBSTATION UPGRADE PROJECT**

**WHEREAS**, Brewster Village Council desires to improve and expand the Brewster Electric Southside Substation located on Seventh Street E., and

**WHEREAS**, the advertisement and Bids for the Installation of the Material and Equipment required to complete the Southside Substation Upgrade Project has been completed according to law, and

**WHEREAS**, the proposed work shall consist of furnishing all necessary labor, supervision, tools, material and equipment (with exception of major equipment furnished by the Village and installed by the contractor) to complete each of the project task items for construction of the Southside Substation Upgrade in the Village of Brewster, Ohio, in accordance with the drawings and specifications which are on file in the office of the Village Administrator.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BREWSTER, THAT:**

**SECTION 1:** It is determined that the Bid in the amount of \$ 1,324,835.00 received from Thompson Electric, Inc. of Monroe Falls, Ohio for the Installation of Material and Equipment listed next was the lowest and best Bid received for the following:

TASK ITEM 100: Demolition	= \$	39,334.00
TASK ITEM 200: Oil Containment	= \$	89,824.00
TASK ITEM 300: Substation Installation	= \$	943,841.00
TASK ITEM 400: Acceptance Testing & Commissioning	= \$	45,336.00
TASK ITEM 500 Alternate: 69kV Pole Line Construction w/o an Outage	= \$	206,500.00
<b>TOTAL Materials &amp; Labor</b>	<b>= \$</b>	<b>1,324,835.00</b>

**SECTION 2:** The Village Administrator and Village Clerk-Treasurer are authorized and directed to execute contracts for the Installation of Materials and Equipment in accordance with the specifications on which the Bid was received. An executed copy of the Contract shall be kept on file in the Village Clerk-Treasurer’s Office.

**SECTION 3:** This ordinance shall be in full force and effect at the earliest date provided by law.
