

**A RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE
BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND
CERTIFYING THEM TO THE COUNTY AUDITOR, AND DECLARING AN EMERGENCY**

WHEREAS, This Council in accordance with the provisions of law has previously adopted a Tax Budget for the next succeeding fiscal year commencing January 1st, 2020; and

WHEREAS, The Budget Commission of Stark County, Ohio, has certified its action thereon to this Council together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Council, and what part thereof is without, and what part within the ten mil limitation; there be it

SECTION 1: RESOLVED, by the Council of the Village of Brewster, Stark County, Ohio, that the amounts and rates, as determined by the Budget Commission in its certification, be and the same are hereby accepted; and be it further

SECTION 2: RESOLVED, that there be and is hereby levied on the tax duplicate of said Village the rate of each tax necessary to be levied within and without the ten mill limitation as follows:

SCHEDULE A

GENERAL FUND -Amount approved by the Budget Commission Inside 10 Mill Limitation = \$99,804
County Auditor's Estimate of Tax Rate to be Levied Outside 10 Mill Limit = \$ 2.80

FIRE FUND - Amount to be derived from Levies Outside 10 Mill Limitation = \$122,599
County Auditors Estimate Rate to be Levied Outside 10 Mill Limit = \$ 4.00

SCHEDULE B

FIRE FUND - Maximum Rate Authorized to be Levied = \$ 4.00.
County Auditor's Estimate of Yield is = \$122,599.

SECTION 3: AND BE IT FURTHER RESOLVED, that the Clerk of this Council be, and she is hereby directed to certify a copy of the Resolution to the County Auditor of said county.

SECTION 4: This resolution shall be deemed an emergency to allow certification to the Stark County Auditor in a timely manner and shall be in full force and effect at the earliest time provided by law.
