

**AN ORDINANCE OF SUPPLEMENTAL APPROPRIATIONS AND AMENDING ORDINANCE 17-2017  
RELATING TO APPROPRIATIONS AND PROVIDING FOR TRANSFER OF FUNDS WITHIN SAID  
APPROPRIATIONS FUNDS FOR THE FISCAL YEAR ENDING DECEMBER 31, 2017**

**WHEREAS**, the Village Clerk-Treasurer has advised Village Council that a reallocation of the funds that were provided in Ordinance 17-2017 is necessary, and

**WHEREAS**, Brewster Village Council wishes to amend Ordinance 17-2016 to authorize such an allocation of funds.

**NOW THEREFOR, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BREWSTER, OHIO, THAT:**

**SECTION 1:** That there be and hereby is transferred within the 2017 appropriation within the General Fund of the Village of Brewster, Ohio, the following:

\$ 25 from A1-6B-240 O&M-Street to A1-4A-212 Zoning Benefits  
\$ 4,975 from A1-6B-240 O&M-Street to A1-4A-240 Zoning O&M  
\$ 500 from A1-7C-236 Legal Services to A1-7C-239 Misc Services  
\$ 1,500 from A1-7E-250 Capital Outlay-General to A1-7E-211 Wages-General  
\$ 500 from A1-7E-250 Capital Outlay-General to A1-7E-212 Benefits-General  
\$18,000 from A1-7E-250 Capital Outlay-General to A1-7E-240 O&M-General

**SECTION 3:** That there be and hereby is transferred within the 2017 appropriation within the Education and Enforcement Fund of the Village of Brewster, Ohio, the following:

\$ 500 from B13-1X-234 Police Education to B13-1X-211 Wages  
\$ 500 from B13-1X-234 Police Education to B13-1X-212 Benefits

**SECTION 4:** That there be and hereby is transferred within the 2017 appropriation within the Police Training Fund of the Village of Brewster, Ohio, the following:

**SECTION 6:** That there be and hereby is transferred within the 2017 appropriation within the Water Fund of the Village of Brewster, Ohio, the following:

\$ 500 from E1-5C-250 Capital Outlay to E1-5C-248 Training-Water  
\$ 4,000 from E1-5C-250 Capital Outlay to E1-5C-246 Repairs-Water

\$ 3,000 from E3-5X-262-1 Interest-Omega JV5 to E3-5X-261-1 Principal-Omega JV5
